DETAILS OF OUR RALLY

Marchwood is at the top end of Southampton Water opposite the container port and might be thought rather depressing as a rally venue, although the comings and goings of very large container ships do make an interesting spectacle. However it does boast a very friendly member-run yacht club where we have always been sure of a great welcome. Walk-ashore pontoon mooring at £10 per boat regardless of length make a welcome change to higher fees charged elsewhere and the promise of beer at £2 per pint is another attraction.

With the nights drawing in and the prospect of a warm friendly bar we shall forego any pontoon party and gather in the clubhouse from around 1800 with a view to sitting down to eat at 1900.

The cost for a three-course meal is expected to be in the region of £25, and we will make any necessary adjustments on the day.

All being well there should be an Officer of the Day from the club supervising mooring arrangements.

NB Mooring fees are included in the rally fee. Water is available on the pontoon, but not electricity.

NOTES ON THE GENERAL CONDITIONS APPLICABLE TO THE RUNNING OF A MEET, RALLY OR CRUISE-IN-COMPANY

1. Vessels attending the events are to be covered by adequate third party and public liability insurance. Minimum £2,000,000 for any one accident;
2. The Event Organisers and Organising Body shall not be in any way liable for any loss, damage, death or personal injury howsoever caused to the owner, skipper, his/her crew or other persons on a boat, as a result of their taking part in the Meet, Rally or Cruise-in-Company. Moreover, every skipper/owner warrants the suitability of his/her yacht/boat for the Meet, Rally or Cruise-in-Company and that his/her boat is insured for taking part in the Meet, Rally or Cruise-in-Company;
3. When on a Meet, Rally or Cruise-in-Company with the CA the safety of any yacht/boat and her entire management including insurance shall be the sole responsibility of the owner/skipper who must ensure that the yacht/boat is fully found, thoroughly seaworthy and manned by a crew of sufficient number and experience who are physically fit to face bad weather. The owner/skipper must be satisfied as to the soundness of the hull, spars, rigging, sails and all other gear. He/she must ensure that all safety equipment is properly maintained, stowed and in-date and that the crew know where it is kept and how it is to be used.

PLEASE CONFIRM:

The vessel is insured with:(name of company) and I have Third Party and Public Liability insurance cover of at least £2,000,000 for any one accident. My insured cruising range covers the area relevant to this event. I am aware that the Cruising Association and the Rally organisers accept no responsibility for the safety of my vessel, or its crew. The decision to sail and all handling of the vessel and its tender are the responsibility of the skipper who should take his decisions knowing the abilities of his vessel and of his crew.
